

## THE STIRLING ARMS HOTEL STANDARD TERMS & CONDITIONS

The person making the reservation is deemed to have accepted all the following terms and conditions on behalf of the booked party.

## BOOKING

- 1. Prices shown are per room per night for the number of persons and dates selected. Additional guests where permitted, will be charged an additional nightly charge.
- 2. The booker should refer to the 'Terms & Conditions and Payment Policy' on the booking confirmation page for full details of the payment required to secure a booking.
- 3. The booker should refer to the 'Cancellation Policy' on the booking page for full details on cancellation dates and applicable charges. Any refunds approved will be at the Manager's discretion.
- 4. Amendments are subject to approval and may result in additional fees, based on the new published rate.
- 5. The rates cannot be amended once bookings are confirmed and specials cannot be used in conjunction with any other offer.

## PAYMENT

- 1. On completion of the booking, the applicable payment will be charged to credit card details provided.
- 2. All credit card payments will attract a 1.5% surcharge for Visa and MasterCard and Amex.
- 3. Local loyalty members must present their loyalty card to staff upon check-in to redeem any special accommodation offers.

## GENERAL

- 1. A confirmation email will be forwarded to you once your booking is complete; it is the guest's responsibility to advise the property should they not receive written confirmation and to read carefully to ensure their booking is correct.
- 2. Check in time at all properties is 1400 and check out at 1000. Early check in and late check-out are at the discretion of the property and must be requested on the day applicable. There will be no refund for early check out and a late checkout fee may apply if a property is not vacated prior to arranged check-out time.
- 3. Upon arrival, full payment of the accommodation will be taken, less any prior deposits. Cash bonds will not be accepted.
- 4. On checking-in to the hotel and signing the registration card you accept all hotel terms & conditions. You are held liable for any damage to the hotel accommodation that you have hired and have caused and you accept all liability including any debt recover costs / legal fees.
- 5. All guests under the age of 18 must be accompanied by a parent or guardian. The hotel reserves the right to refuse bookings where there is not a registered guardian accompanying minors.
- 6. Valid photo ID for each booking must be produced and match the name of the booking to the guest/s checking in.
- 7. Whilst we attempt to satisfy all special requests we are unable to provide a guarantee.
- 8. The Stirling Arms Hotel urges guests to have fully covered travel insurance. The Stirling Arms Hotel accepts no responsibility or liability for guest's personal belongings or motor vehicles.
- 9. Provision of complimentary cots and highchairs is on an availability basis. These should be arranged with the property directly prior to arrival.
- 10. All rooms offer tea and coffee making facilities, complimentary bathroom amenities, linen, and towels. Guests staying 7 or more nights will receive a weekly service.
- 11. While smoking is allowed in designated areas of the property, all accommodation rooms are non-smoking.
- 12. The Stirling Arms Hotel does not have a 24-hour reception. For arrivals after hours, guests must contact the property directly during office hours to obtain arrival instructions and how to collect their keys.
- 13. The Stirling Arms Hotel offer complimentary car parking. This is subject to availability and on a first come first serve basis.
- 14. Free Wi-Fi is provided daily for up to 500mb (resets every 24 hours). Additional access is available for purchase.
